



On Large Deviation Principles for Trajectories of Random Walks

The existing version of the Large Deviation Principle for trajectories of random walks was established under very restrictive assumptions on the decay rate of the jump distributions at infinity. We prove that a Large Deviation Principle of such kind actually holds under much more relaxed conditions. Moreover, the very statement of the problem, including the class of random walks under consideration, has also been generalized.
